NOTICE OF 42ND ANNUAL GENERAL MEETING

(IST) through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM") to transact the following businesses:

ORDINARY BUSINESS:

1. To receive, consider and adopt the Audited Financial Statements of the Company for the financial year ended 31st March, 2022 along with the Report of Board of Directors and Auditors thereon.
2. To appoint a Director in place of Mr. Lalit Kumar Pareek (DIN: 01078494), who retires by rotation in terms of Section 152(6) of the Companies Act, 2013 and being eligible offers himself for re-appointment.
3. To re-appoint Statutory Auditors of the Company and to consider and if thought fit, to pass the following resolution, as an Ordinary Resolution:

"RESOLVED THAT pursuant to the provisions of Sections 139, 141, 142 and other applicable provisions, if any, of the Companies Act, 2013 read with the Companies (Audit and Auditors) Rules, 2014 (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force), and pursuant to the recommendations of the Audit Committee and the Board of Directors of the Company ("the Board") accorded at their respective meetings held on 30th May, 2022, Messrs. Bandyopadhyay & Dutt, Chartered Accountants(Firm Registration Number 325116E), be and are hereby re-appointed as the Statutory Auditors of the Company for a second term of 5 (five) consecutive years from the conclusion of this 42nd Annual General Meeting till the conclusion of the 47th Annual General Meeting of the Company to be held for financial year ending 31st March, 2027 at such remuneration as shall be fixed by the Board of Directors of the Company, based on the recommendations of the Audit Committee.

Pursuant to General Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020 and Circular No. 02/2021 dated January 13, 2021 and General Circular No. 02/2022 dated 5 May 2022 (hereinafter referred to as “MCA Circulars”) issued by the Ministry of Corporate Affairs (“MCA”), read with the Securities and Exchange Board of India (“SEBI”) Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, Circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated 13 May 2022 (hereinafter referred to as “SEBI Circulars”) and the relevant provisions of the Companies Act, 2013 (as amended) (the “Act”) and Rules made thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) (the “Listing Regulations”) the Company is convening its 42nd Annual General Meeting (the “AGM”) through video conferencing (“VC”) or other audio visual means (“OAVM”) without the physical presence of the Members. The deemed venue for the AGM will be the Registered Office of the Company.

2. The Explanatory Statement pursuant to Section 102 of the Act setting out material facts concerning the business under Item No. 3 forms part of the Notice convening the 42nd AGM of the company (the “Notice”) and the details required under Regulations 36(3) & 36(5) of the Listing Regulations and Secretarial Standard on General Meetings (SS- 2) issued by the Institute of Company Secretaries of India, in respect of Director seeking re-appointment at this AGM is furnished as an Annexure to the Notice.

3. In terms of the MCA Circulars and the SEBI Circulars mentioned hereinabove, the requirement of sending proxy forms to holders of securities as per provisions of Section 105 of the Act read with Regulation 44(4) of the Listing Regulations has been dispensed with. Therefore, the facility to appoint proxy by the Members will not be available and consequently, the proxy form and attendance slip including route map are not annexed to this Notice.

4. Members attending the AGM through VC or OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.

5. 11.Regulation 40 of Listing Regulations, as amended, mandates that transfer, transmission and transposition of securities of listed companies held in physical form shall be effected only in demat mode.

Further, SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated January 25, 2022, has clarified that listed companies, with immediate effect, shall issue the securities only in demat mode while processing investor service requests pertaining to issue of duplicate securities certificate, claim from unclaimed suspense account, renewal/exchange of securities certificate, endorsement, sub-division/splitting of securities certificate, consolidation of securities certificates/ folios, transmission, transposition etc. In view of this, Members holding shares in physical form are requested to consider converting their holdings to demat mode. 12. VOTING THROUGH ELECTRONIC MEANS

- I. In compliance with the provisions of Section 108 of the Act and Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of the Listing Regulations read with the MCA/SEBI Circulars in relation to e-Voting Facility provided by Listed Entities, the Company is pleased to facilitate its Members, to transact businesses as mentioned in the AGM Notice by voting through electronic means (e-Voting). For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a Member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.



II. THE INTRUCTIONS FOR SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:

- (i) The remote e-voting period commences on **Sunday, 18th September, 2022 at 10.00 A.M. and ends on Tuesday, 20th September, 2022 at 5:00 P.M.** During this period Members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date **Wednesday, 14th September, 2022**, may cast their vote by remote e-voting. The remote e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 9th December, 2020 on 'e-voting facility provided by Listed Companies', e-voting process has been enabled for all the individual demat account holders, by way of single login credential, through their demat accounts/website of Depositories / DPs in order to increase the efficiency of the voting process. Individual demat account holders would be able to cast their vote without having to register again with the e-voting service provider ('ESP') thereby not only facilitating seamless authentication but also ease and convenience of participating in e-voting process. Shareholders are advised to update their mobile number and e-mail ID with their DPs in order to access e-voting facility.

However, Members holding shares in demat form will now reach 'Password Creation' menu wherein they are required to mandatorily enter their login password in the new password field. Kindly note that this password is to be also used by the demat holders for voting for resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential.
- (vii) For Members holding shares in physical form, the details can be used only for e-voting on the resolutions contained in this Notice.
- (viii) Click on the EVSN for the relevant Company Name i.e. **PURBASHA RESOURCES LIMITED** on which you choose to vote.
- (ix) On the voting page, you will see "**RESOLUTION DESCRIPTION**" and against the same the option "**YES/NO**" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- (x) Click on the "**RESOLUTIONS FILE LINK**" if you wish to view the entire Resolution details.
- (xi) After selecting the Resolution you have decided to vote, click on "**SUBMIT**". A confirmation box will be displayed. If you wish to confirm your vote, click on "**OK**", else to change your vote, click on "**CANCEL**" and accordingly modify your vote.
- (xii) Once you "**CONFIRM**" your vote on the resolution, you will not be allowed to modify your vote.



- (xiii) You can also take out print of the voting done by you by clicking on “**Click here to print**” option on the Voting page.
- (xiv) If Demat account holder has forgotten the same password then enter the User ID and the image verification code and click on **Forgot Password** & enter the details as prompted by the system.
- (xv) There is also an optional provision to upload BR/POA if any uploaded, which will be made available to scrutinizer for verification.
- (xvi) **Additional Facility for Non – Individual Shareholders and Custodians –Remote Voting only**
 - Non-Individual shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on to www.evotingindia.com and register themselves in the “Corporates” module.
 - A scanned copy of the Registration Form bearing the stamp and sign of the entity should be emailed to helpdesk.evoting@cdslindia.com.
 - After receiving the login details a Compliance User should be created using the admin login and password. The Compliance User would be able to link the account(s) for which they wish to vote on.
 - The list of accounts linked in the login will be mapped automatically & can be delink in case of any wrong mapping.
 - A scanned copy of the Board Resolution and Power of Attorney (POA) which they have issued in favour of the Custodian, if any, should be mandatorily uploaded in PDF format in the system for the scrutinizer to verify the same.

III. INSTRUCTIONS FOR SHAREHOLDERS ATTENDING THE AGM THROUGH VC/OAVM & E-VOTING DURING MEETING ARE AS UNDER:

1. The procedure for attending meeting & e-Voting on the day of the AGM is same as the instructions mentioned above for Remote e-voting.
2. The link for VC/OAVM to attend meeting will be available where the EVSN of Company will be displayed after successful login as per the instructions mentioned above for Remote e-voting.
3. Shareholders who have voted through Remote e-Voting will be eligible to attend the meeting. However, they will not be eligible to vote at the AGM.



4. The facility for the Members to join the AGM through VC/OAVM will be available 30 minutes before the meeting and may close not earlier than 30 minutes after the commencement of the AGM.
5. Shareholders are encouraged to join the Meeting through Laptops / IPads for better experience.
6. Further shareholders will be required to allow Camera and use Internet with a good speed to avoid any disturbance during the meeting.
7. Please note that Participants Connecting from Mobile Devices or Tablets or through Laptop connecting via Mobile Hotspot may experience audio/video loss due to fluctuation in their respective network. It is therefore recommended to use Stable Wi-Fi or LAN Connection to mitigate any kind of aforesaid glitches.
8. Shareholders who would like to express their views/ask questions during the meeting may register themselves as a speaker by sending their request in advance at least **5 days prior to AGM** mentioning their name, demat account number/folio number, e-mail id, mobile number at prl@purbasha.co.in. The shareholders who do not wish to speak during the AGM but have queries may send their queries in advance **5 days prior to AGM** mentioning their name, demat account number/folio number, e-mail id, mobile number at prl@purbasha.co.in. These queries will be replied to by the Company suitably by e-mail.
9. Those shareholders who have registered themselves as a speaker will only be allowed to express their views/ask questions during the meeting.
10. Only those shareholders, who are present in the AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system available during the AGM.
11. STATE OF COMPANY'S AFFAIRS:

IMPACT OF COVID-19 PANDEMIC

FY 2021-22 continued to be a challenging year due to COVID-19 and it was dominated by the pandemic as new waves of infection swept across countries. The advent of highly transmissible variant 'Omicron' in the early January, 2022 spread much dread across the world. During this third wave India's daily number of reported cases peaked but fortunately it was not as much deadly. While many got infected they also recovered without hospitalization and had lower mortality. The Company has been monitoring the situation closely and has taken various measures to comply with directions / regulations / guidelines issued by the Government and local bodies to ensure safety of employees at workplace. Despite the challenges, uncertainties and complexities the laid down systems, processes and proactive strategic interventions which form part of your Company's operating practices have aided your Company's ability to ensure business continuity.

OPERATIONS

During the year under review, the revenue from operations of your Company decreased from ₹ 490.00 lacs in the Previous Year to ₹ 411.99 lacs. The Operating Income of the Company is derived from a mix of dividend, sale of shares and securities, profit from sale of investments and future/derivatives and interest income. The profit after tax for the year under review is ₹ 145.22 lacs as against profit of ₹ 566.32 lacs in the Previous Year 2020-21.

SHARE CAPITAL:

There has been no change in the financial structure of the Company during the year under review. As on 31st March, 2022, the Authorised Share Capital of the Company stood at ₹ 3,50,00,000/- comprising 33,00,000 Equity Shares of ₹10/- each and 20,000 Non Cumulative Redeemable Preference Shares of ₹ 100/- each. The Issued, Subscribed and Paid up share capital of your Company stood at ₹ 3,00,10,000, comprising 30,01,000 Equity shares of ₹ 10/- each.

DIVIDEND:

The Board of Directors of your company after considering holistically the relevant circumstances has decided that it would be prudent, not to recommend any Dividend for the year under review.

RESERVES:

The Board of Directors of your company has transferred ₹ 150.00 lacs to General Reserves and ₹ 29.04 lacs to the Statutory Reserves in terms of Section 451C of the Reserve Bank of India ("RBI") Act, 1934 for the financial year ended 31st March, 2022.

DEPOSITS:

Your company being a Non-Systematically Important Non-Deposit taking, Non-Banking Financial Company (NBFC) registered with RBI did not hold any public deposits at the beginning of the year nor has it accepted any public deposits during the year under review. The Board has duly passed a resolution in their meeting giving effect to the said statement.



PARTICULARS OF LOAN, GUARANTEES AND INVESTMENTS:

Your Company is a Non-Banking Financial Company registered with RBI having principal business of making investments and giving loans in the ordinary course of business, hence the provisions of Section 186 of the Companies Act, 2013 (the "Act") do not apply to the Company. Further the Company has not provided any guarantee/security during the year under review.

RELATED PARTY TRANSACTION:

All related party transactions that were entered into during the financial year were undertaken in the ordinary course of business and at arm's length basis, none of the transactions with related parties falls under the scope of Section 188(1) of the Act. Hence, provisions of Section 188 of the Act are not applicable. Thus, disclosure in Form AOC-2 in terms of Section 134 of the Act is not required.

All Related Party Transactions were placed before the Audit Committee for its approval and were reviewed on quarterly basis. Further, necessary disclosure as required under IND AS 24 with respect to related party transactions are disclosed under Note No. 28 of the Notes on Financial Statements for the FY ended 31st March, 2022.

MANAGEMENT DISCUSSION AND ANALYSIS

Purbasha Resources Limited is a Non-Systematically Important Non-Deposit Taking, Non-Banking Financial Company (NBFC-ND) registered with the Reserve Bank of India. The principal business activity of the Company is making investment and giving loans. The Company invests in both listed and unlisted companies. The Entire business of the company deals in two segments – dealing in shares and financing. During the year under review the total market value of quoted investments is ₹ 1330.75 lacs as compared to ₹ 1205.70 lacs in the Previous Year. The total book value of investments is ₹ 276.60 lacs as compared to ₹ 116.57 lacs in the Previous Year. The interest income on loans and advances is ₹ 39.90 lacs as against ₹ 33.16 lacs in the Previous Year. The Company endeavours to evaluate opportunities considering the macro economic conditions both globally and domestically.

THE COVID 19 PANDEMIC AND ITS IMPACT ON THE ECONOMY

The beginning of the FY 2021-22 was dominated by Covid-19 pandemic as new waves of infection swept across the world. In India, the second wave (called 'Delta') proved far more lethal than the first that struck in 2020. The highly transmissible variant 'Omicron' in early January 2022 (the third wave) spread rapidly across the world. During this wave, India's daily number of reported cases peaked but fortunately it was not as much deadly.

As compared to previous years there was not much contraction in GDP this year. The increase in pace of vaccination across the country coupled with proper wearing of mask and following of social distancing norms helped in bringing down the surge of pandemic. Consequently, the strong link between COVID-19 waves and fall in GDP growth seem to have considerably reduced.

The pandemic has disrupted the lives and livelihood of millions of people and affected economies across the world but it gave the world a new chance to reinvent itself to adapt to new ways of life and business.

INDIAN ECONOMY OVERVIEW

The Indian economy had begun to recover since the second half of FY2021. Amidst the challenges brought by the COVID-19 pandemic leading to disruptions and the Russian invasion of Ukraine in the latter half of the year, geo-political turbulence arising from the war in Ukraine and restraints on trade resulted in economic volatility. In spite of this, the Indian Government introduced various policies to cushion the impact on the domestic economy and in specific vulnerable sections of society and the business sector. India quickly overcame the pandemic's headwinds. India's GDP is estimated to have expanded 8.7% in FY 2021-22 against a contraction of 6.6% in FY 2020-21. The Indian economy is in a good position to witness GDP growth of around 8.0%-8.5% in 2022-23.



OUTLOOK

Non-banking financial institutions play an important role in facilitating credit intermediation in India as an alternative to bank financing, as NBFCs specialize in offering loans to niche areas and cater to specific sectors. NBFCs have played an important role by providing funding to the unbanked sector by catering to the diverse financial needs of the customers. However the risks that the sector poses led the RBI issue 'Scale Based Regulation' (SBR) to make the financial sector sound and resilient while allowing a majority of NBFCs to continue under the regulation-light structure. The objective behind this scale based approach is to perceive the risk associated with the NBFCs considering their size and activity. The surge of pandemic and the geopolitical turbulence has stressed the sector but with the advent to vaccination driven optimism and government policies it has been able to reach its pace.

OPPORTUNITY AND THREATS

The relaxations in regulatory reforms and aid from Government to combat the present situation will pave way for the industry to overcome the variable market conditions. Any slowdown in the growth of Indian economy or future volatility in global financial market, impulsive law making and bad political environment distressed business could adversely affect the business.

RISKS AND CONCERNS

Globally companies were affected due to the disruption caused in carrying out operational activities consequent to COVID-19 pandemic. The Company is tracking emerging macro risks which may emerge from Russia-Ukraine conflict, worldwide monetary policy stance of central banks, continued supply chain disruptions and commodity prices. Their impact on inflation over the mid-term and slowdown on GDP growth/recovery are areas that the Company continues to monitor and respond with adequate actions. This may pose some challenges to the business of the Company. The growth of the Company is linked with the growth of economy also. Further, unforeseen natural disasters and geopolitical problems may also have an adverse impact on the Company's business. The Company takes all measures to address all possible risks and mitigate them effectively.

INTERNAL CONTROL SYSTEMS

The Company has an effective internal control system to ensure reliable financial reports, operating effectiveness and overall efficiency. All its activities comply with applicable laws and regulations. The Company has adequate internal control systems proportionate with the size and nature of its business being framed in a manner which ensures optimum resource utilisation and strict compliance with all statutes. The audit committee reviews the adequacy of the internal control systems and follow-up actions are implemented immediately, if required.

HUMAN RESOURCES

The Company firmly believes that Human Capital is its most important asset. Despite the pandemic bringing new challenges before the Company, it continued to evolve its practices in supporting its employees through the challenging times. The company believes in retaining talent and to foster a work culture that is always committed to providing the best opportunities to employees to realize their potential.

Opinion

NOTES FORMING PART OF THE FINANCIAL STATEMENTS

1.	General corporate information
	PURBASHA RESOURCES LIMITED ('the Company'), incorporated in the year 1980, is a registered Non Banking Financial Company, engaged in providing finance and dealing in shares and securities. The Company is listed at Calcutta Stock Exchange Limited.
	The functional currency and presentation currency of the Company is Indian Rupee ("₹") which is the currency of the primary economic environment in which the Company operate.
2.	Summary of Significant Accounting Policies
2.01	Statement of Compliance
	The financial statements have been prepared in accordance with Ind AS notified under the Companies (Indian Accounting Standard) Rules, 2015. The financial statements have also been prepared in accordance with the relevant presentation requirements of the Companies Act, 2013. Further, the Company has complied with all the directions prescribed for Non-Banking Financial Companies (NBFCs).
2.02	Basis of Preparation and Presentation
	These Standalone financial statements of the Company are prepared under the historical cost except for certain financial instruments that are measured at fair value at end of each reporting period. Historical cost is generally based on fair value of the consideration given in exchange for goods and services.
2.03	Use of Estimates
	The preparation of separate financial statements in conformity with the recognition and measurement principles of Ind AS requires the management of the Company to make estimates and assumptions that affect the reported balances of assets and liabilities, disclosures relating to contingent liabilities as at the date of the separate financial statements and the reported amounts of income and expense for the periods presented.
	Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and future periods are affected.
2.04	Revenue Recognition
	i) Derivative Income
	In respect of derivative contracts gains/losses on settlement are recognised in the profit and loss statement.
	ii) Dividend and Interest Income
	Dividend income is recognised when the shareholder's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Company and amount of income can be measured reliably).
	Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the asset's net carrying amount on initial recognition.



	Sale and purchase of shares and securities are recognised on transfer of significant risks. Sale is stated at net of taxes and charges on transactions while purchases are inclusive of transaction charges and taxes.
2.05	Borrowing Costs
	Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use.
2.06	Employee Benefits
	Short-term Benefits
	Short term employee benefits are recognised as an expense at the undiscounted amount in the statement of profit and loss of the year in which the related service is rendered.
2.07	Taxation
	i) Current Tax
	Current tax is payable based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the Standalone statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.
	ii) Deferred Tax
	Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the Standalone financial statements and the corresponding tax bases used in the computation of taxable profits. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profit will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.
	Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, joint ventures and associates, except where the Company is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from the deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which the benefits of the temporary difference can be utilised and they are expected to reverse in the foreseeable future.
	The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.
	Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.



	iii) Minimum Alternate Tax
	Minimum Alternate Tax (MAT) paid in accordance with the tax laws, which gives future economic benefits in the form of adjustment to future income tax liability, is recognised as an asset in the balance sheet when there is convincing evidence that the Company will pay normal income tax during the specified period and it is probable that future economic benefit associated with it will flow to the Company.
	iv) Current and deferred tax are recognised in profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. The current and deferred tax arising from the initial accounting for business combination, are included in the accounting for the business combination.
2.08	Property, Plant and Equipment
	Fixed assets are carried at cost less accumulated depreciation and impairment losses, if any. The cost of fixed assets includes interest on borrowings attributable to acquisition of qualifying fixed assets up to the date the asset is ready for its intended use and other incidental expenses incurred up to that date. Machinery spares which can be used only in connection with an item of fixed asset and whose use is expected to be irregular are capitalised and depreciated over the useful life of the principal item of the relevant assets. Subsequent expenditure relating to fixed assets is capitalised only if such expenditure results in an increase in the future benefits from such asset beyond its previously assessed standard of performance.
	The Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as of April 1, 2019 measured as per the previous GAAP and use that carrying value as its deemed cost as of the transition date.
2.08.1	Depreciation
	Depreciation is calculated on cost of items of property, plant and equipment less their estimated residual value using straight line method over the useful lives of the assets estimated by the company based on internal evaluation and is recognised in the profit and Loss account.
2.09	Impairment of Assets
	At the end of each reporting period, the Company reviews the carrying amounts of its tangible and intangible assets (Other than goodwill) to determined whether there is any indication that those assets have suffered any impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash generating unit to which the asset belongs.
	Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.
	Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and risks specific to the asset for which the estimates of future cash flows have not be adjusted.
	If the recoverable amount of an asset or cash generating unit is estimated to be less than the carrying amount, the carrying amount of the asset or cash generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit and loss.

	When an impairment loss subsequently reverses, the carrying value of the asset or cash generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset or cash generating unit in prior years. Any reversal of an impairment loss is recognised immediately in profit and loss.
2.10	Inventories

	When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.
2.11.02	Contingent Liabilities and Assets
	Contingent liability is a possible obligation that arises from past events and the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company, or is a present obligation that arises from past events but is not recognised because either it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation, or a reliable estimate of the amount of the obligation cannot be made. Contingent liabilities are disclosed and not recognised. Contingent assets are neither recognised nor disclosed.

Statutory Reserve as per Section 45-IC of the RBI Act, 1934

Statutory Reserve represents reserve fund created pursuant to Section 45-IC of the RBI Act, 1934 through transfer of specified percentage of net profit every year before any dividend is declared. The reserve fund can be utilised only for limited purposes as specified by RBI from time to time and every such utilisation shall be reported to the RBI within specified period of time from the date of such utilisation.

Capital Redemption Reserve (CRR)

Capital Redemption Reserve represents reserve created pursuant to provisions of erstwhile Companies Act, 1956 by transfer of an amount equivalent to nominal value of the Preference shares redeemed. The CRR may be utilised by the Company, in paying up unissued shares of the Company to be issued to the members of the Company as fully paid bonus shares in accordance with the provisions of the Companies Act, 2013.

General Reserve

General Reserve is created through annual transfer of profits at a specified percentage in accordance with applicable regulations under the erstwhile Companies Act, 1956. Consequent to introduction of the Companies Act, 2013, the requirement to mandatorily transfer specified percentage of net profits to General reserve has been withdrawn. However, the amount previously transferred to the General reserve can be utilised only in accordance with the specific requirements of the Companies Act, 2013.

Retained Earnings

Retained Earnings or accumulated surplus represents total of all profits retained since Company's inception. Retained earnings are credited with current year profits, reduced by losses, if any, dividend payouts, transfers to General reserve or any such other appropriations to specific reserve.
